7. MINUTES OF THE MEETING held on 13 APRIL 2010, having been previously circulated, were held to be a true and correct record of that Meeting. PROPOSED by Cllr. Simpson. SECONDED by Cllr Carr. ALL IN FAVOUR.

8. CLERK'S REPORT

Following sightings of Traffic Wardens booking illegally parked vehicles on the day of the Street Fair, the Clerk has written to the Chief Executive of the City of York Council to ask why this had happened when, ordinarily, traffic wardens are hardly ever seen here, and pledging the support of the Parish Council for this community event. A copy has also been sent to Cllr Healey, but no reply has yet been received.

The Clerk and Chairman have visited the Borthwick Institute in order to view the document necessary to proceed with the registration of the Burial Ground. Unfortunately, the document was missing and is believed, by the Institute staff, to be in the possession of the Diocesan Registrar. The Clerk has now written to him in an attempt to try and trace the document and progress matters.

A reply to the Clerk's letter to CYC re the pothole in Westfield Lane is still awaited. Cllr Healey to pursue.

A quote for insurance cover has been received from Aviva. Once we have a renewal quote from our current insurers, Zurich, the Clerk and Chairman of the Finance Committee will meet to discuss how best to proceed.

Confirmation of our registration under the Data Protection Act is received.

Four places have been reserved for the Localism in Action conference to be held in September..

9. WARD COMMITTEE

Following receipt of a complaint about construction vehicles parking on the footpath on Top Lane, Cllr Healey has spoken to the drivers and asked the Traffic Wardens to monitor the situation.

The next Ward Team Meeting will take place at 12.00 noon on 21 May.

10. POLICE LIAISON

There have been a number of instances of "cold calling" in the village. The police have involved the Trading Standards Office and they may set up a Cold Calling Control Zone. There has also been some anti-social behaviour, and this will henceforth be attended by a Response Officer, rather than a PCSO.

There have also been 2 attempted burglaries, and reports of youths congregating near the railway line on the public footpath between Copmanthorpe and Bishopthorpe.

12. ASKHAM BRYAN COLLEGE

Cllr Whitfield has circulated comprehensive notes from a meeting held with Representatives of Askham Bryan College, and the Youth Liaison Group will follow up certain items without delay.

- a) The Parish Council to ask Sgt Andy Haigh to be aware of new students at the College in September.
- b) The Parish Council to invite any student s who so wish to attend Parish Council meetings.
- c) The College to be asked to make use of the Village Newsletter (as it has done this month), to ascertain ways in which our residents can support the College.
- d) Ask in the village library if provision could be made for students to use their Student Cards there.
- e) Seek the College's help with the wildflower meadow.
- f) The Youth Liaison Group to facilitate contact between the village school and the College, particularly in regard to the school's garden and a possible adventure playground.

13. CORRESPONDENCE

Yorkshire Homes, acting on behalf of Yorkshire Housing, asked the Parish Council to help in advertising a property for sale in Moorland Gardens. This had to be advertised locally in the first instance, and has now been sold.

The Art Exhibition, which is part of the Carnival, is now advertising for entrants. Councillors agreed to sponsor 2 display boards, as we have done in previous Years, if we are asked, at a cost of £10 each.

CYC Rural Housing Enabler, Mr Ben Botham, has contacted us regarding Affordable Housing. The Parish Council considered this some time ago, and concluded that there are already sufficient affordable homes in Copmanthorpe. The Parish Council believes that this remains the case.

North Yorkshire County Council Minerals Core Strategy First Consultation is received. No comments to make.

In recognition of the Parish Council's financial support the **Occasion Choir** is pleased to offer a number of complementary tickets for its forthcoming concert in St Andrew's Church, Bishopthorpe. Proceeds of the concert will go towards the provision of treatment at York Hospital for sufferers of Myasthenia Gravis.

14. REPORTS FROM COMMITTEE CHAIRMEN

a) Planning

Approvals are received for 25 St Nicholas Road, 7 Sutor Close and 34 Top Lane (trees).

b) Roads and Footpaths

We are informed that work to begin the installation of the additional light on the opposite side of the road to the Royal Oak will be completed in the next couple of weeks.

The proposal for an extra litter bin on Low Green has not yet been approved by Neighbourhood Services, and it is thought unlikely that this will proceed. The Clerk to contact the resident who had concerns about the location of any new bin. No further litter picks are planned with CPRE, but Cllr Bowen is liaising with a group in the village who wish to carry one out, and will provide them with the necessary equipment.

Some issues were raised at the Street Fair – an overgrowing hedge, and a request for an additional bus shelter on Temple Lane.

The storage cupboard and filing cabinet are now installed in the Howell Hall.

The bench planter has been relocated to the Burial Ground.

The small metal posts in Reygate Grove have been marked for attention.

c) Finance
