Before the business of the Meeting began Mr Tim Duffy, Chairman of the newly formed Copmanthorpe Windfarm Action Group, which is opposed to the proposal for a Windfarm on land to the west of Manor Heath, addressed the Council. The Group, which includes a number of people with expertise in relevant fields, will hold its first Committee meeting tomorrow evening in order to formulate its objections to the 80 metre monitoring mast. It is also their intention to formally object to the application for the Windfarm, on a number of grounds. The Group wants to look at the possibility of holding a Public Meeting to hear the views of those who were not able to attend the exhibition staged by Banks Renewables last week, and it is likely that this will be very well attended. The Planning Committee of the Parish Council would like to see a Public Meeting towards the end of March/beginning of April.

An exit poll of the approx 718 people who did attend showed that 83% were opposed to the Windfarm, 8% in favour and the rest unsure. Should this view be confirmed by the Public Meeting, it is proposed that a draft dossier be prepared in anticipation of the full planning application. It is known that Rufforth Parish Council will support us in whatever we decide to do as they, along with Askham Bryan Parish Council, are opposed to this possible development. It may prove necessary to engage outside experts to help with this dossier.

7. WINDFARM

Cllrs Whitfield and Mrs Townsend had attended a seminar in Ripon organised by several local MPs and NYNET on superfast broadband. Middlethorpe Business Park currently has superfast broadband and NYNET will speak to them about the possibility of some of their unused bandwidth being made available to Copmanthorpe residents, possibly through a wireless network.

Approvals have been granted at 23 Station Road and Viking Cottage, Moor Lane. The application at 61 Barons Crescent has been refused. There has been an application for a Liquor Licence at the former newsagents. The manager of the Co-op has expressed her concerns that the Licence will allow for the sale of alcohol up to 11.00 pm and this could cause problems in the village late at night.
