# 4. CLERK'S REPORT

CYC Enforcement Officer, Andy Blane, informs us that a letter from the City's Solicitor is to be sent to the dentist advising him that legal action will be taken regarding his advertising sign. If no heed is taken of this, it will be followed by a suumons to court.

YLCA advises that following revisions by certain Parish Councils to the Charter, and a meeting with CYC in March, no further comments have been received. Cllr Peter Powell (Upper Poppleton) will be reporting to YLCA on this next week. Cllr Bowen expressed his concern that those Parishes which commented have not been provided with a copy of the latest revisions.

#### 5. NORTH YORKSHIRE POLICE

The problems on Low Green appear to have subsided, and in general the village is fairly quiet.

#### 6. ACTION REVIEW

#### 7. WINDFARM – Update

The final results of the Ballot at the closing date, 20<sup>th</sup> June, were 242 against the proposed Windfarm and 25 in favour.

The application was refused on the grounds that it would be inappropriate development in the Green Belt for which very special circumstances have not been demonstrated. It would harm the openness of the Green Belt and have a detrimental impact on the visual amenity of the area and the setting and historic character of the City of York. Contrary to Policy GB1, SP2 and SP3 of the Development Control Local Plan and paragraph 13 of Planning Policy Statement 22 'Renewable Energy' and guidance in Planning Policy Guidance 2 'Green Belts'. However, the applicant has 6 months in which to appeal.

#### 8. GREEN ENERGY POLICY

After some discussion, and picking up a suggestion from the Copmanthorpe Windfarm Action Group, Cllr Bowen PROPOSED that the Parish Council investigate the legislation in the Climate Change and Sustainability Act 1996, whereby a Council can promote a microgeneration and energy conservation policy. SECONDED by Cllr Mrs Taylor. ALL IN FAVOUR. It was further AGREED that a Steering Group be formed, to consist of Cllrs Bowen, Carr, Mrs Taylor and the Rev Mumford. Cllr Mrs Taylor to contact Mr Graham Auton, CWFAG, to set up a first meeting to discuss the name of this new Cllr Mrs group and its remit.

#### 9. RESIDENTS' ASSOCIATION

A request has been made for a recognised crossing from the doctors' surgery on Horseman Lane to the shops. Julie Hood, CYC, will deal with this.

#### 10. CORONATION CUP

All certificates have been signed by the judge, Cllr John Galvin, and by the Lord Mayor, Cllr David Horton who lives in Copmanthorpe. Cllr Mrs Townsend PROPOSED that the Clerk write to Cllr Galvin to formally thank him for judging the competition. SECONDED by Cllr Mrs Taylor. ALL IN FAVOUR.

#### 11. TASK FORCE

Cllr Bowen will prepare a simple risk assessment and instructions for each volunteer on each occasion that the Task Force is working in the village. The Cllr first areas of vegetation to be tackled are Low Green/Loriners Drive, Low Bowen Green/Merchant Way, and the railway bridge.

#### 12. KEEP BRITAIN TIDY

**Halcrow** have been commissioned to carry out a survey on peoples' satisfaction or otherwise with taxi and hackney cab provision in York. Cllrs expressed no strong feelings on this issue.

Approvals are received for 18 Barons Crescent and 15 Horseman Lane. The application for the wind monitoring mast on land to the east of the village has been refused.

# b) Roads and Footpaths

Cllr Bell has prepared proposals for the purchase and use of snow clearing equipment, hopefully in conjunction with the Recreation Centre with whom a meeting is needed to discuss, along with any other interested parties. It is proposed that any major equipment purchased could and should be used by the Recreation Centre in the summer months. Cllr Bell PROPOSED that we should proceed along the lines suggested in this document. SECONDED by Cllr Carr. ALL IN FAVOUR.
