2. DECLARATIONS OF INTEREST

3. MINUTES OF THE MEETING held Tuesday, 12 July 2011, having been previously circulated, were held to be a true and correct record of that Meeting. PROPOSED by Cllr Simpson. SECONDED by Cllr Mrs Auton. ALL IN FAVOUR.

4. CLERK'S REPORT

The sign at the Dental Surgery has now been removed.

Details are received of availability and prices for brown rock salt. This should form part of our discussions re winter snow clearance provision. At a meeting with the Recreation Centre they intimated that they would be happy in principle to store a vehicle for this purpose, should the Parish Council go ahead with such a purchase. It is hoped to find something which could be useful to the Recreation Centre during the rest of the year.

Agreement in principle to the siting of a notice board at the school has been reached. Cllr Simpson to liaise with Cllr Bell and the school caretaker re actual location.

5. NORTH YORKSHIRE POLICE MATTERS

The village is generally fairly quiet although a small amount of anti-social behaviour is still occurring.

A black Audi A3, believed to have been involved in the theft of a Land Rover, has been seen circling the Moor Lane area and other streets.

A large number of charity bags, awaiting collection by the British Heart Foundation, have been picked up by an unauthorised vehicle.

6. CORONATION CUP

Following the prize giving, an article appeared in the Press which contained a number of inaccuracies. To prevent this happening in future years it was AGREED that a press release be issued by the Parish Council immediately after the prizes have been awarded.

7. TASK FORCE

Arrangements for tidying Loriners Drive last Saturday had to be abandoned due to extremely heavy rain. Cllr Bowen will try to rearrange this and will contract those Councillors who offered help when he has a suggested date.

It is noted that the path around the School has now been attended to by their Contractors, however the footpaths Low Green/Reygate Close, Low Green/Top Lane and Croft Farm Close/Merchant Way are in need of attention.

It is suggested that Community Payback could be used for this latter, as Cllr there is much to be done here.

b) Roads and Footpaths

A report has been received from a resident of Station Road that there is a lot of straw on the highway, which has come from farm vehicles moving through the village, and is causing the drains to block. This has been reported to CYC who say they will clear it up in due course.
