#### 2. DECLARATIONS OF INTERST AND DISPENSATIONS

#### 4. CLERK'S REPORT

A second tree in the burial ground has fallen. The Clerk will therefore arrange for a survey of all the trees there to judge their safety and ascertain whether or not any should be removed as a precautionary measure.

A complaint has been received from a resident of Temple Lane regarding traffic speeding along that road. She will report the matter to the police, and the Clerk has assured her that we are aware of the problem, and work closely with the police on all matters with which they are involved in Copmanthorpe.

The Company responsible for works on the A64 is not able to change the signage on that road without instructions from the Highways Agency, and they suggest that we ask them to re-visit our request for signage to Copmanthorpe on the Westbound carriageway. The Company also outlines its reasons for the chosen route for the diversion of traffic during the forthcoming night time works to renew signage on the A64 Askham Bryan Westbound Exit Slip Road.

#### 5. NORTH YORKSHIRE POLICE

Anti-social behaviour continues to be a problem, with a number of incidents relating to the throwing of snowballs during recent bad weather. More worrying are the incidences of tyre-slashing, theft of a vehicle's number plates and damage to walls and fences in recent months. After some lengthy discussion it was AGREED that Cllr Simpson should ask the police for advice on how we can best help them to improve the situation and apprehend those responsible.

#### 6. DRAFT POLICE AND CRIME PLAN

The recently elected Police and Crime Commissioner has prepared the first draft of the Plan, which will set out in detail how the police will work in this area. This first draft is subject to consultation, and the Parish Council gave its responses to the 4 point strategy and 10 point questionnaire as part of this exercise.

#### 7. RURAL WEST YORK

Cllr Healey reported that CYC's Highway Asset Manager is asking the Council to approve a programme of works which includes the resurfacing of Horseman Lane and Merchant Way in 2013-14. A decision will be taken on 21 March.

Hallcroft Lane and Top Lane are currently being considered for inclusion in the list for 2014-15. No mention is made of Flaxman Croft, the other area of significant damage to road surface which had been put forward by Cllr Carr in his report to CYC as requiring attention.

The Clerk to ask Cllr Dave Merrett for an assurance that the budget for these essential works will not be raided for repair works to roads along the route to be taken by the Tour de France next year.
