2. DECLARATIONS OF INTEREST AND DISPENSATIONS

3. MINUTES OF THE MEETING held Tuesday 12 March 2013, having been previously circulated, were held to be a true and correct record of that Meeting. PROPOSED by Cllr Simpson. SECONDED by Cllr Smith. ALL IN FAVOUR.

4. CLERK'S REPORT

We have two quotes for the works to the trees in the burial ground. None of the work required is urgent, and the two quotes differ somewhat as to what is required. Discuss at next meeting.

Following the death of Mrs Margaret Chapman-Andrews, Lady of the Manor of Copmanthorpe, the Clerk has been informed by her son, Peter, that it is he, and not his own son, Thomas, who will succeed to the title. There is nothing to be done at this time, but the Clerk will be keeping in touch with Mr Chapman-Andrews.

There is now one whole, and one half, plot available at the allotments. However it is likely that one of these will be taken this week.

The Clerk has asked that the footpath widening work on Church Street, opposite the Co-op, be carried out as agreed.

Road resurfacing at Top Lane/Horseman Lane and Merchant Way will be carried out during this new financial year 2013-14.

5. NOTH YORKSHIRE POLICE

Crime figures have been falling until the last month. Two youths have been dealt with for smashing windows. Cllr Steward is trying to organise a question and answer session for Copmanthorpe with the Police and Crime Commissioner.

6. TENDER FOR GRASS CUTTING

The two tenders received having been previously circulated, Cllr Carr PROPOSED that the Parish Council accept the less expensive of the two quotes, from Brighter Gardens. SECONDED by Cllr Smith. ALL IN FAVOUR.

7. HOWELL HALL AND YOUTH CLUB

Following the appointment of a Youth Leader, the Youth Club will formally re-open on 24 April at 7.15 pm. There will be a banner across the building to advertise this open house event, and Tadcaster School is helping to promote the Club. Twitter and Facebook are also being used for promotion. The Club is now a Registered Charity so there will be no liability for Council Tax. Bookings for use of the Hall by other groups and individuals are up, but the Howell Hall Management Committee is still in need of a Secretary.

8. TRANSPORT AND PARK AND RIDE

A meeting has been arranged by Mr Julian Sturdy, MP with the bus company to discuss the service they provide. This will be in Haxby Methodist Church on 19 April, between 4.00 and 5.30 pm.

9. ALLOTMENTS

The dykes have now been cleared and cleaned up. The new Tenancy Agreements have been sent out to all plot holders with the invoices for the forthcoming year's rent.

10. CORONATION CUP

The first meeting of the organising committee has been held. A judge has been appointed, and posters advertising the competition will be going up around the village very soon. Cllr Simpson PROPOSED that that the judge she should be paid £75 per evening. SECONDED by Cllr Mrs Auton. ALL IN FAVOUR.

11. SCHOOL ACCESS FROM LOW GREEN

As stated in the Clerk's Report, City of York Council have been instructed to carry out the Scheme as agreed with them.

12. RURAL WEST YORK

Following a consultation exercise, there are to be changes to the library service in Copmanthorpe and a reduction in staff there. One of their staff will come to the next Parish Council to explain what is happening. Two part-time staff will be lost, so there will only be one librarian there in the daytime.

The street lighting service is to be brought back in house, and there will be no-one driving around the village once a month to check on the lights. Residents will have to report any faults.

13. COMMUNITY AUDIT AND NEIGHBOURHOOD PLAN

Cllr Mrs Auton had attended the last meeting of the Community Plan Focus Group. A questionnaire is to be sent to every home in the village. They have a fund of £6,000 to do everything they want to do. They believe that there are three groups In the village who are in need: young Mums with young children but who intend going back to work within the year; latch-key kids aged 11-12 years; and those over 80 years old.

No date has been set for the next meeting. The questionnaire is to be delivered by green couriers, but we need to see it before it goes out.
