1. APOLOGIES

2. NEW COUNCILLOR

Mr Brian Bell was welcomed back to the Council, and signed his Declaration of Acceptance of Office, which was witnessed by the Clerk.

3. DECLARATIONS OF INTEREST AND DISPENSATIONS

4. MINUTES OF THE ANNUAL GENERAL MEETING held TUESDAY 14 MAY 2013, having been previously circulated, were held to be a true and correct record of that Meeting. PROPOSED by Cllr Smith. SECONDED by Cllr Whitfield. ALL IN FAVOUR.

5. CLERK'S REPORT

6. CYC DRAFT LOCAL PLAN AND NEIGHBOURHOOD PLAN

After a number of meetings it is now clear what the implications of the Draft Local Plan as it currently stands will be for Copmanthorpe. The Parish Council needs to decide how best to respond to this. After some discussion it was AGREED that an Action Group should be formed to oppose the Draft Plan, and that we should also accelerate the Neighbourhood Plan in order to be able to put this forward as a credible alternative to CYC's proposals.

We need to persuade as many people as possible to go to the two meetings next week – the Exhibition in the Howell Hall on Tuesday and the Ward Meeting on Thursday evening.

Cllr Smith will approach Mr Matthew Liston, who had expressed a wish to be involved in any efforts to object to the proposals in the Local Plan proposals so far as it relates to Copmanthorpe, to ask if he would be willing to be involved in, and hopefully co-ordinate, an Action Group.

Cllr Whitfield will design a leaflet, to go to every house in the village, asking for support with the Action Group, with a template letter of objection.

Cllr Carr will draft a detailed letter from the Parish Council, listing all our concerns and objections, for submission before the end of the consultation period, 31 July. This letter will also make reference to the Neighbourhood Plan, which, if it is to be adopted, will need to have the backing of the village.

Cllr Healey advised that, following the entire consultation exercise, the final Local Plan will be available in February 2014. It was AGREED that we should aim to have the Neighbourhood Plan complete by November this year and, if necessary, be willing to pay for professional expertise to ensure that the document is as robust as possible.

Cllr Healey promised to get the full list of sites which were offered by landowners when the Call for Sites was issued, and also the criteria used in choosing which sites should be put forward.

7. BOUNDARY COMMISSION REVIEW

The proposals contained in the Review are based on a population increase in Copmanthorpe of just 9 people over the next five years. It is hard to see how this sits with a need for even 300 houses in the same period of time. Copmanthorpe would be stand alone Ward with just one Councillor. Rural West would encompass all the villages that it currently has, with the addition of Skelton. The Clerk to respond. Clerk

One further letter of support for this has been received from a resident. After a lengthy discussion on the need for this in Copmanthorpe, Cllr Mrs Townsend PROPOSED that we respond with a suggestion that additional Vehicle Activated Speed Signs would be a better use of the money. 11. HOWELL HALL AND YOUTH CLUB

Last week 44 young people attended the Youth Club. There are 2 new volunteers but more are still needed.

12. PUBLIC TRANSPORT AND PARK AND RIDE

A report had been circulated. Since the meeting in Haxby organised by Julian Sturdy MP there has been no further news on the number 13 bus service.

Work on the new Park and Ride site is now well underway.

13. CORONATION CUP

After a slow start a total of 11 adult entries and 4 children's entries have been received, the youngest competitor being a little boy aged 3. Judging by Kymm Queen will take place on 17th and 18th June, and the prize giving will be at the Horticultural Show in the Methodist Church on 13th July.

14. BURIAL GROUND TREES

The original report and 2 quotes for suggested work to the trees are to hand. The work would be best carried out in the autumn, together with the planting of any new or replacement trees.

15. CARNIVAL

Carnival Day, 6 July, is another opportunity to draw people's attention to the Local Plan. Hopefully all three Ward Councillors will be there at some time during the afternoon. Cllrs Simpson, Mrs Taylor and Mrs Townsend will not be available. The Clerk will draw up a Rota for manning the stall.

16. VILLAGE PHOTOGRAPHIC ARCHIVE

Cllrs Whitfield and Mrs Taylor have had preliminary discussions about this, and are considering a competition and an exhibition. This will probably be some time in the winter.

E-planning is to be fully implemented by the end of this year, although paper plans will still be sent out for proposals of more than 20 properties. We will need to purchase a laptop, projector and screen, and Cllrs Smith, Whitfield, Simpson and Mrs Taylor will form a Group to discuss what is required, and how costs might be shared with the Youth Club/Howell Hall and possibly a Community Cinema.
