10. NEIGHBOURHOOD PLAN

Cllrs David Carr and Megan Taylor had attended a meeting with representatives of CYC Planning Department. Historic England believes that the group should produce a Strategic Environmental Assessment. It is likely that the Neighbourhood Plan will then need some small revisions before going out for 5 weeks consultation in Copmanthorpe. This will be followed by 6 weeks consultation carried out by CYC, before final submission to the Examiner, hopefully by the end of October.

The Plan will need to fulfil CYC's criteria on Affordable Housing, but we are not obliged to designate any "safeguarded" land.

11. FOOTBRIDGE ACROSS THE RAILWAY LINE

We are informed by Network Rail that they are not now going to pursue the closure of the level crossing at the present time. They have indicated that they would be happy to talk to us about a possible crossing to link Rec Centre 2 with the village, if that proposal goes ahead.

12. RECREATION CENTRE and REC CENTRE 2

No report. The Rec Centre 2 project is dependent on its inclusion in the Neighbourhood Plan, and ultimately on funding from the Football Association.

13. DRAFT LOCAL PLAN

The new Draft Local Plan, based on much reduced, but not yet finalised, housing numbers, should be ready by the end of June and will then go out to public consultation.

14. WARD COMMITTEE

An application has been made by the Howell Hall, for funding to improve the entrance porch.

A group of residents would like the herb garden at Horseman Close to be tidied up, and a quote for this work has been received from Brighter Gardens in the Sheet 4

sum of £220. Cllr Whitfield PROPOSED that the Parish Council apply for a grant to do this work, on behalf of the residents. SECONDED by Cllr Brian Bell. ALL IN FAVOUR.
