These amendments will be made, with a view to formal adoption of these new Standing Orders next month.

14. NEIGHBOURHOOD PLAN and DRAFT LOCAL PLAN

The Neighbourhood Plan Group is still trying to resolve the question of the wording to be used in relation to making changes to the Green Belt. Cllr Mrs Taylor is still seeking advice from CYC as to a form of words which will satisfy both them and the Examiner.

The YLCA is hosting a Meeting about Neighbourhood Plans in Huntington on 27th September.

The next stage of the consultation on the Draft Local Plan will begin next Monday, 18th September. The new Draft is unchanged from the previous Version but now includes the Ministry of Defence land which is to become available at Strensall and Imphal barracks. The two sites proposed in Copmanthorpe should provide 250 houses, however Cllr Carr believes that developers will be pressing for three times as many as this. The results of the consultation will be analysed at the end of October. Any amendments required will be made and the Publication Draft will then go to central government.

15. RECREATION CENTRE

No meeting was held in August.

16. FRACKING

The representative from iGas does not yet have the information we require from him, so he will come to either the October or November meeting of the Parish Council.
