Before the business of the Meeting began Mr Alan Murray reported on a meeting which had taken place on 18 January with a view to setting up a village Neighbourhood Watch scheme. He asked whether the Parish Council might be interested in a joint approach to the current problem of increased numbers of burglaries in the village and be willing to provide any financial support. The minutes of this meeting were circulated and there is information in the February Newsletter. The possibility of a link to the Parish Council website was discussed, and Cllr Carr said that, if the group wanted a stand-alone site, there may be Ward funding available from next year's budget.

#### 15. DRAFT LOCAL PLAN

Two Inspectors have now been appointed to consider the Draft Local Plan and assess the sites put forward, as well as the number of houses required over the next fifteen years.

#### 16. LOCAL COUNCIL ELECTIONS

Local Council elections will take place on 2 May, for both Parish and City Councils. The Clerk has recently attended a briefing by the Deputy Returning Officer, CYC, and will co-ordinate nominations from Councillors currently serving. Nomination packs should be available by the end of February, and forms need to be returned to CYC, by hand, between 27 March and 4 April.

#### 17. COMMUNITY EVENT

A Community Event is planned for the evening of 7 December, in the vicinity of the Royal Oak and Memorial Green. There are plans for a brass band, the Community Choir and a Living Nativity in the beer garden of the pub. Mince pies and mulled wine will be available, as well as pies and peas provided by Little Acorns. St John's Ambulance Service has been booked to provide First Aid if necessary, and it is hoped that the school and churches will become involved.

# 18. DEFIBRILATOR

The defibrillator has now been delivered, and the Clerk is seeking permission from the owners of the bus shelter on Tadcaster Road to site the equipment on the shelter.

#### 19. OLD SCHOOL MEDICAL CENTRE

The threat to the Bishopthorpe surgery has now been lifted, and it may be possible to extend that building to increase capacity.

#### 20. HERITAGE TRAIL

#### 21. SPEEDWATCH

The existing volunteers are now trained, and one more has come forward. It is,

however, proving difficult to get sufficient people together at any one time during daylight hours, and the group has deployed only once.

## 22. CORRESPONDENCE

We have been informed of a crisp packet recycling scheme in Dunnington, and the possibility of doing something similar here was put forward, perhaps at the Recreation Centre. Cllr Auton will take this forward.
