# 4. CLERK'S REPORT

# 5. ACTION REVIEW

Due to current social distancing requirements it has not been possible for Cllrs Whitfield and Mrs Taylor to clean the telephone kiosk on Horseman Lane which now houses the defibrillator.

Our grass cutting contractor cannot deal with the large docks in the verge at Colton Lane crossroads because of their proximity to a water course, so CYC

Highways will have to deal with these as part o their normal verge maintenance.

The VE Day celebrations planned by the Parish Council could not take place due to the current prohibition on social gatherings, but banners had been placed on the railings around the war memorial, a number of residents had put out bunting, and St Giles had a display of poppies in the churchyard.

For the same reasons, no progress has been made on any meeting with GoodGym, treatment of the new gate at the allotments, or the CYC gardening assistance scheme.

# 7. COPMANTHORPE WARD

The Community Covid-19 support hub at Howell Hall is being wound down. The demand has not been as great as had been anticipated, and CYC will remove what stock is left in the Howell Hall this week and carry out a deep clean. After an initial rush to deliver a backlog of prescriptions from the pharmacy, the Copmanthorpe and Bilbrough Top Covid-19 Support Group similarly had more volunteers than were actually required, and has been very quiet for the last couple of weeks. It should be noted that a very good number of residents came forward to offer help.

After much pressure from Cllr Carr, Hallcroft Lane is to be resurfaced during this financial year.

Green bin collections, which normally resume at the beginning of April, are to commence city-wide on 18th May.

A response from central government to Phase 1 of the Local Plan Inquiry is expected this month, but this may be delayed due to the Covid-19 situation.

Two separate lots of graffiti have been removed from the railway bridge in recent days.

Magson/Cllr Magson will design some posters to go in the Co-op and post office, and on village notice boards, and will also promote the competition on social media.

#### 9. PHOTOGRAPHIC ARCHIVE

Cllr Mrs Taylor reported that she has taken photographs around the village during this period of lockdown, to be added to the Village Archive.

#### 10. CORRESPONDENCE

Following some correspondence about proposed works to a tree in the Top Lane/Low Green footpath a resident is concerned that her name has been given, in a letter from the Clerk, to someone else without her permission. The Clerk had written, in good faith and in the knowledge that the parties had spoken on at least two occasions, and with the intention of seeking to protect members of the public who use that path whilst any work is carried out, and has since spoken to the husband of the lady in question who appears content to let the matter rest.

It was AGREED that, whilst there has not been a significant breach of GDPR and the event does not merit reporting to the Information Commissioner, we need to be sure in future that no personal information is passed to a third party without express consent from the owner of that information.

#### 11. LAND AT FARMERS WAY

The outcome of the Minister of State's decision on the Public Right of Way, Yorkfield Lane, is awaited.
