2. DECLARATIONS OF INTEREST and DISPENSATIONS

5. ACTION REVIEW

The damaged bollard at the car park has been reported to CYC, and the Clerk will write to the owner of the car park to thank him for recent repairs and urge further improvements.

Some patching work has been carried out on Manor Heath by CYC, but a lot of potholes still remain.

There is a lot of litter around the pond on the approach to the Park and Ride site, and also on the verge of the westbound side of the A64, for quite a distance beyond the sliproad.

It is noted that the tree guards have never been removed from the trees on the approach road from London bridge garage.

The verge edges in the village need some attention and the Clerk will ask
Community Payback if this is something they could deal with.

9. YORKFIELD LANE and the PROPOSED CLOSURE OF BECKETTS RAILWAY CROSSING

A further meeting with representatives of Network Rail, City of York Council, Bishopthorpe Parish Council, Julian Sturdy's office, and other interested parties will take place in the Howell Hall on Monday, 20th March at 3.00 pm. The aim of the Meeting will be to discuss any suggestions which Network Rail may have which would achieve our stated aim of making the crossing accessible to wheelchair users and pushchairs, anyone with reduced mobility, and cyclists.

10. COMMUNITY SPEEDWATCH

We now have all our own equipment, as well as additional hi-visibility vests. Sadly, only three of the group of sixteen volunteers have responded to Cllr Mrs Taylor's email regarding resumption of deployments.

11. VEHICLE ACTIVATED SPEED SIGNS

Cllr Carr has obtained two quotes for these signs, to be supplied and installed by CYC with a choice of two locations. The full estimated cost of installation for a standard VAS sign, with a 6 year warranty, would be £5,800. For a sign with a SID (Speed Indicator Device) it would be £6,400. Cllr Auton had previously obtained a number of quotes, the best of which was approx. £2,500.

Cllr Carr had indicated that he would have some Ward money available to put towards this but at this stage is not able to state exactly how much.

It appears that the Parish Council is not to be permitted to purchase a sign of its own choosing, but is required to pay for one from only two options given by CYC. After some discussion around getting best value for money, and the lack of any breakdown of the costs from CYC (purchase price and installation costs) the Chairman PROPOSED acceptance of the £6,400 quote. A vote was taken, with two members in FAVOUR, and four AGAINST.
